

3. **The objectives of the Trust shall be**

- A. To establish, maintain and run Schools, Colleges, Social service centers, Industrial Training centre.
- B. To establish, Training Centre, and allied education institutions.
- C. To establish, Cultural, and Social Institutions,
- D. To Spread for promotion of education and learning in all branches
- E. To advance Indian Culture and Literature, Service of this Country for the benefit of our Nation.
- F. To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- G. To establish research and training centers for the furtherance of education/learning in its various fields and branches.
- H. To undertake propaganda, training and education of the masses either of its own or in co-operation with similar Agencies working for the cause of all round development of the Society.
- I. To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- J. To function as a Non-communal Trust and as a secular organisation.
- K. To establish centers for employment generation.
- L. To acquire and maintain the movables and immovable properties for achieving and said objects.
- M. To advance any other objects of general public utility.
- N. To confer title on eminent personality in the field of science, education, literature, etc.,
- O. To establish the colleges to impart education in the area of higher education especially the emerging field like, Electronics, Bio-technology, and other allied fields.
- P. To Establish Hostel to the students.
- Q. To Provide Scholarship to the Merit Students.
- R. To Provide Old age Home for the aged Persons

- S. To establish the welfare of the women and to launch a programme under Women's welfare.
- T. The funds of the Trust shall be invested in the modes specified under the Provision of section 13(1)(d) r.w.s. 11(5) of the I.T. Act,1961 as amended from time to time.
- U. There shall be maintained all accounts of the Trust regularly. The accounts shall be duly audited by Chartered Accountant. Every Year, the accounts shall be enclosed by 31st March.
- V. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provision of sections 2(15),11,12 & 80G of the I.T. Act,1961 as amended from time to time. FURTHER NO AMENDMENT SHALL BE CARRIED OUT WITH OUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME TAX.
- W. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustee members of the managing Committee/Govt. body but the same shall be transferred to another Trust whose objects are similar of those of this Trust and which enjoys recognitions u/s 80G of the I.T. Act,1961, as amended from time to time.
- X. The trust formed shall be Irrevocable.
- Y. The benefits of the Society shall be open to all respective of caste, creed or religion.
- Z. The Funds & the Income of the Trust shall be solely utilized for the achievement of its objectives & no portion of it shall be utilized for payment to the Members by way of profit, dividends, etc.
- AA. Objects/activities of the Trust not for any particular Community/Religious, it is purely for General Public.
- BB. The profit and Income obtained by this organization, need not to be distributed among the trustees, but it is to be used only for the improvements of the organization and to make expenditure for the Trust itself.

CONSTITUTION OF THE FIRST TRUST BOARD:-

3. Shri. Kempa Raju aged 40 years CHAIRMAN & PRESIDENT
4. Smt, Bharathi Kemparaju aged 30 years SECRETARY

The persons herein before referred to as Trustees shall constitute, the first Board of Trustees,

In case of a vacancy by the death, resignation or expulsion or otherwise or for any other caused legally conceivable reasons the remaining trustee may fill up the vacancy by appointing likeminded person, As a member of the date of occurrence of such a vacancy. Till the Vacancy or vacancies are filled up the remaining trustee shall be deemed variously constituted board of trustees.


In case of the office bearers, on life trustees, resign as otherwise relinquish from office any office, then the remaining trustees shall elect any other trustees among themselves to hold such an office.

POWERS OF THE BOARD OF TRUSTEES:-

To perform and exercises the following act and deals and Powers:-

1. The entire Management and control of the properties and funds shall be in the Board of trustees. The trustees themselves or through their duly authorized Agents and Employees, manage the affairs of the trust or deal with the trust properties and funds in any manner as may beneficial to the interest and object of the trust.

2. Demand and money payable and receivable by the trust and give effectual receipt and discharges by themselves or through their accredited agents or Employees.
3. Advance money, investments recoveries set arise, earmarked deposit in Nationalized Banks or otherwise deal with the money or funds of the trust, not immediately require for the objects of the trust may be decided by the Board of Trustees in consistent with provision of section 13(1)(4) of the Income Tax act.
4. Borrow or revise funds with or without security from any Banks or from any Private party or Government or any other Financing Agencies in any manner, The Board of Trustees think proper and expedient or house by conducting any Exhibition, should or terms of entertainment, permitted by law or derive for the Purpose of receiving money or funds or collections for furthering the objects or Purpose of the Trust.
5. To sue, and sued or compromise any legal actions or other proceeding in any court of law or authorities or bodies and do all such acts incidental here to.
6. The Board of trustee may delegate any or all their powers to any one or more to them for such time and such purposes as they deem fit.
7. The Board may constitute such subcommittee, as may be necessary consisting Of trustees or non-trustees from time to time for any specific purpose and may Invite any perform as a special invites and to dissolve such committees at only Time in the discretion of the Board of Trustees.
8. In addition to above, the trustees in pursuance of law central or State Government and administration of the charitable Trust shall do such things And acts accordingly.
9. Any Non life trustees may retire by giving 30 days notice in writing to the managing Trustees of the trust
10. The office of the trustees shall be honoring but they are to draw such allowance As may be decided by the board from time to time for carrying out their duties, Relating to and in furtherance of the aims and objects of the trust.

11. The trustees are wholly indemnified agent any recovered expenses incurred or less suffered or any payments made to project the interest of trust by them and such expenses and payments shall be in any manner be personally responsible for the same
12. The Board of trustees shall have power to appoint or employ persons like qualified teachers, superintendents, Accountants, Managers clerks, secretary etc., As may be necessary from time to time and such remuneration to discharge or remove them and in their place appoint and employ others.
13. It shall be lawful for the Board of trustees at such time or times as they may in their absolute discretion think fit to sell by public auction or private contract or exchange or transfer or assign or grant lease or immovable properties for any term, however long or otherwise dispose of all or any part of house fund. All moneys from any such transfer or other assurance shall be deemed to be part of trust fund and shall be applied accordingly.
14. The trustees may deposit any investments, securities or any documents held by them relating to any property belonging to the trust under these presents with any Banks or Bankers in furtherance of the objects of the trust and may be remunerated to commission engaged or other sums payable in respect of such deposit or for the collection of the interest, incidence, or other income of the trust
15. It is hereby declared that the president and secretary trustees shall have absolute power to dismiss any of the Non life trustees apart from founder trustees in the object of the trust. Similarly the president and secretary shall have absolute powers to appoint or dismiss .any of the employees.
16. The president and secretary trustees shall also have power to appoint employees to the trust and similarly shall have absolute discretionary powers to dismiss the services of any of the employees.
17. The trustees shall have power to receive Subscription, Donations, Deposits, Contributions, Gifts, Grants etc., from the government and other public bodies, corporate sectors, individuals etc., the trustees shall have also powers to acquired

by way of purchase, gifts, grants, or otherwise, property of every description for the use and benefit to the trust calculation to promote the aims and objects thereof.

MEETING

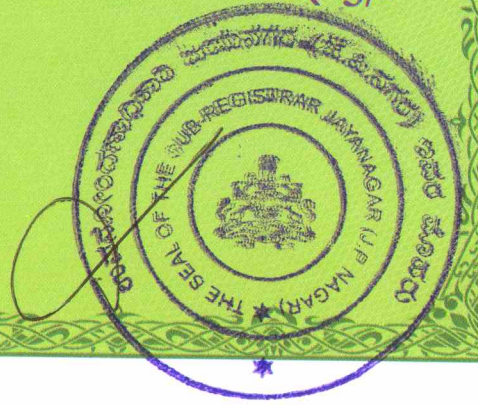
1. The Board of trustees shall meet at least once in every three months to consider and transact the affairs of the trust
2. The quorum of the meetings shall be for and no quorum is necessary for the adjourned meeting.
3. A minimum of 3 days notice shall be given to the trustees of such meetings.
4. It however, in any emergency in the opinion of the managing trustee and life trustee the calling of a meeting is impracticable for any reasons to be recorded in writing, The Managing Trustees may get opinion of the trustees by circulating to the Trustees and the same shall be placed before the next meeting of the Board and get the same ratified.
5. In case the managing trustee of the trust fails to convene three consecutive meetings and four trustees by themselves may convene a meeting by giving notice of 15 days to the other trustees.
6. The presiding officer among the Managing Trustees of a meeting shall have a casting vote in any issue. In case of elections the Managing Trustee shall not be entitled to Exercise the casting vote.
7. Notice, of all meetings shall be sent by circulatory book /or under certificate of posting.
8. The Managing Trustee in his absence, one of the life trustee shall preside at the Meeting of the Board, If the Managing Trustee and life trustee are absent, meeting shall be postponed for the available date of Managing trustee.

POWER AND DUTIES OF LIFE TRUSTEES

1. Subject of the control of the Board of Trustee, the Managing Trustee shall be in sole charge of the entire functions of the Board of Trustees and shall be entitled to act for, on behalf of, and in the name of the Board of Trustees with out prejudice to the foregoing general authority granted to the Managing Trustee. The Managing Trustee shall maintain or cause to be maintained all accounts of Income from trust properties, operate of Bank Accounts of income from trust properties, operate on Bank accounts from trust and incur expenditure for the administration of the trust. Co
2. Ilect funds and take all action and legal or other proceedings before any court of authority whatsoever in the name of the trust as may be decided by the Board of trustees from time to time.
3. The President and secretary jointly can delegates all or any of the foregoing powers to anyone or more of the Trustees and may revoke delegation of such authority at any time.
4. The Managing trustee/trustees may be permitted to draw such remuneration as may be determined by the Board of Trustees, but such remuneration shall not be altered to his prejudice during his term of office.

1. LIFE TRUSTEE:

Life Trustees discharge such functions and duties as assigned from time to time by the managing trustee, which he/claims for the interest of smooth functionary of the Trust
